The 2024 John H. Lorenzen Scholarship and Achievement Award

The Scholarship and Awards Committee is honored to present the Scholarship and Achievement Award in memory of the late John H. Lorenzen.

John began his career with the Maine Department of Corrections in 1973 when he accepted a position as a guard at the Maine State Prison following his college graduation. In 1974, John enlisted in the United States Air Force. When his enlistment ended, John transitioned to law enforcement in 1983 when he accepted a position as a police officer with the Rockland Police Department. It was during this time as a Police Officer, that John had the opportunity to work with probation officers (PO) and juvenile community corrections (JCCO) and felt he could have a bigger impact on his community if he became a probation officer. In 1989, John embarked on a journey that would change the trajectory of so many lives. John was hired by Maine Department of Corrections (MDOC) as a JCCO but due to state budget cuts, was laid off. John returned to patrol work, with Thomaston Police Department. John's passion for community corrections never ceased and in 1996, he returned to the Maine Department of Corrections. In 2000, John transitioned from working with youth to working with adults as a PO. John worked tirelessly for the next six years as a probation officer. In 2006, John was promoted to a supervisory role. He took great care in nurturing and supporting his staff, always leading by example. In 2022, John retired from state service. His retirement was short lived, 30 days, before returning to the department as a probation officer assistant where he remained until his death in 2022.

For over 30 years, John worked passionately as a probation officer touching so many lives; from the clients he served, to the relationships he built within the department and the community. John was always there, ready to work with a positive and optimistic attitude that was contagious. John participated in many departmental initiatives and was instrumental in the initial rollout of evidence-based practices, case planning, upgrades to our data bases, policy changes, and countless others. John's entire adult life was dedicated to his family, public service, and serving the people of the State of Maine and the United States. John was a constant support to the clients he worked with, a friend to his coworkers and later, a mentor to the officers he supervised.

The John H. Lorenzen Scholarship is awarded to those students who have exhibited excellence in the areas of academic achievement and leadership. Recipients must exhibit characteristics/values that embody a positive and determined attitude.

Eligibility Requirements for the John H. Lorenzen Scholarship and Achievement Award:

- Student must be enrolled full-time at an accredited college.
- Student must be enrolled in a four-year degree program.
- Student must be a New England resident or attending a college in New England.

For 2024, awarded scholarship amount will be **\$4000.00**

To Apply:

To be considered for the John H. Lorenzen Scholarship and Achievement Award, students must electronically submit the following to the Scholarship Committee of NECCD (see below) no later than:

August 31, 2024:

- Official college document that accurately reflects your current enrollment and GPA.
- Two letters of recommendation.
- A Service Record to document any type of Community Service that has been completed.
- A letter of support from one of the locations Community Service was completed at.
- 500-word essay of how the award of this scholarship will assist with the completion of your degree in your chosen major, as well as your career goals. You are required to mention civic, athletic, and community engagement and how this engagement makes you a qualified candidate for the award.

*Late submissions will not be accepted. Incomplete applications will not be considered. The anticipated award will be announced during the NECCD Annual Conference. All information will be kept confidential, except for the information that will be needed for the public announcement of the award.
